PAYMENT SCHEDULE: Your photography fee is \$_____ with a deposit of 50% (\$_____) due at the signing of this agreement, and the balance (\$_____) to be paid on the date of the wedding.

SERVICES INCLUDED FOR THE FEE STATED ABOVE: All useable photographs digitally enhanced and provided digitally to Client. 8 hours of wedding coverage. In addition - Engagement session, studio and / or location of metro location of client's choosing.

ENTIRE AGREEMENT: This agreement contains the entire understanding between Autumn Lee Studios and the CLIENT. It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing, signed by all the parties. If the parties want to waive one provision of this agreement, which does not mean that any other provision is also waived. The party against whom a waiver is sought to be effective must have signed a waiver in writing.

COOPERATION: The parties agree to cheerful cooperation and communication for the best possible result within the definition of this assignment. Autumn Lee Studios recommends that CLIENT designate an "event guide" to point out important individuals for informal or candid photographs to the photographer during the wedding that they wish to have photographed.

The photographer will not be held accountable for not photographing desired people if there is no one to assist in identifying people or gathering people for photographs. Autumn Lee Studios is not responsible if key individuals fail

to appear or cooperate during photography sessions or for missed images due to details not revealed Autumn Lee Studios.

SHOOTING TIME / ADDITIONS: The photography schedule and selected methodology are designed to accomplish the goals and wishes of the CLIENT in a manner enjoyed by all parties. CLIENT and Autumn Lee Studios agree that cheerful cooperation and punctuality are therefore essential to that purpose. Shooting commences at the scheduled start time.

HOUSE RULES: The photographer is limited by the guidelines of the ceremony official or reception site management. CLIENT agrees to accept the technical results of their imposition on the photographer. Negotiation with the officials for moderation of guidelines is CLIENT's responsibility; Autumn Lee Studios will offer technical recommendations only.

IMAGES COPYRIGHTS: The negatives and or slides are the property of CLIENT for personal use and for the purposes of the reproduction and giving of photographs to friends and relatives. The Client must obtain written permission from and compensate Autumn Lee Studios prior to the CLIENT or its friends and relatives publishing or selling the photographs for profit.

EXHIBITION: CLIENT grants Autumn Lee Studios permission to display selected images resulting from this assignment as an example of Autumn Lee Studios's work and for entrance into photographic competitions and release all claims to profits that may arise from use of images.

MODEL RELEASE: The CLIENT hereby grants Autumn Lee Studios and its legal representatives and assigns, the irrevocable and unrestricted right to use and publish photographs of the CLIENT or in which the CLIENT may be included, for editorial, trade, advertising and any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. The CLIENT hereby releases Autumn Lee Studios and its legal representatives and assigns from all claims and liability relating to said photographs.

LIMIT OF LIABILITY: In the unlikely event that the photographer is injured or becomes too ill to photograph the event, Autumn Lee Studios will make every effort to secure a replacement photographer. If the situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package. Autumn Lee Studios takes the utmost care with respect to exposure, transportation, and processing the photographs.

The noted party agrees that Autumn Lee Studios shall not be liable for any personal injury, loss or damage to property occasioned by any act or omission of the photographer(s). The noted party acknowledges and agrees that the liability of Autumn Lee Studios, its photographers, no matter howsoever caused, is limited to the following refund policy: If Autumn Lee Studios is unable to supply the noted party with any photos from any coverages due to circumstances beyond its immediate, direct and reasonable control, including but without limiting the generality of the foregoing, due to digital film defect, camera or flash or lighting malfunction, then Autumn Lee Studios will give the noted party a refund for the amount paid for the affected coverages; this shall be a prorated amount of the exposures lost based on the percentage of total number of originals.

SECURITY DEPOSITS: In the event of cancellation, the security deposit paid is non-refundable. It shall be liquidated damages to Autumn Lee Studios in the event of a breach of contract by CLIENT. The CLIENT shall also be responsible for payment for any of Autumn Lee Studios' materials charges incurred up to time of cancellation.

COMPLETION SCHEDULE: Eight weeks after the wedding date a complementary DVD with a copyright release will be sent to the couple with all finished images.
